ORDER AMENDING CLEAN WATER ACT SECTION 401 WATER QUALITY CERTIFICATION AND ORDER; AMERICAN PACIFIC NINE MILE, LLC, NINE MILE HILL RANCH PROJECT (WDID NO. 5A52CR00097A3), TEHAMA COUNTY

This Order responds to the 1 November 2024 request for an amendment to the American Pacific Nine Mile, LLC, Nine Mile Hill Ranch Project Section 401 Water Quality Certification (WDID No. 5A52CR00097A2). The original Water Quality Certification (Certification) was issued on 1 December 2009 and amended on 10 April 2020 and again on 26 April 2022. The requested amendment is hereby approved. The original Certification and amendments are therefore amended as described below. Please attach this document to the original Certification and previously approved amendments.

AMENDMENT:

American Pacific Nine Mile, LLC (hereinafter Permittee) is requesting an amendment to the Section 401 Water Quality Certification and Order to extend the expiration date of 10 April 2025 to align with the United States Army Corps of Engineers' permit expiration date of 31 December 2028 (SPK-2005-00601). The request has been approved and the expiration date of the Section 401 Water Quality Certification is **extended to 31 December 2028**.
