**ORDER AMENDING CLEAN WATER ACT SECTION 401 WATER QUALITY CERTIFICATION AND ORDER; BROWNS VALLEY IRRIGATION DISTRICT, JOHN NELSON FISH SCREEN CHANNEL MAINTENANCE PROJECT (WDID NO. 5A58CR00133A2), YUBA COUNTY**

This Order responds to the 22 April 2022 request for an amendment to the Browns Valley Irrigation District, John Nelson Fish Screen Channel Maintenance Project Section 401 Water Quality Certification (WDID No. 5A58CR00133A1). The original Water Quality Certification was issued on 14 September 2017 and amended on 16 February 2022. The requested amendment is hereby approved, and the 16 February 2022 Amendment is therefore amended as described below. Please attach this document to the original Certification.

**AMENDMENT:**

Browns Valley Irrigation District (hereinafter Permittee) is requesting an amendment to the Section 401 Water Quality Certification and Order to extend the current expiration date of 26 April 2023 to align with the expiration date of United States Army Corps of Engineers' Letter of Permission, SPK-2016-00885. Therefore, the expiration date of the Section 401 Water Quality Certification is **extended to 29 March 2027**.
