ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY CONDITIONED WATER QUALITY CERTIFICATION; U.S. FISH AND WILDLIFE SERVICE, HALLWOOD SIDE CHANNEL AND FLOODPLAIN RESTORATION PROJECT (WDID#5A58CR00140A1), YUBA COUNTY

This Order responds to the 11 October 2022 request for an amendment of the Hallwood Side Channel and Floodplain Restoration Project (Project) Section 401 Water Quality Certification (WDID#5A58CR00140). The original Water Quality Certification (Certification) was issued on 14 December 2017. The requested amendment is hereby approved. The original Certification is therefore amended as described below. Please attach this document to the original Certification.

AMENDMENT:

The United States Fish and Wildlife Service (USFWS) is requesting a time extension through 22 December 2025. A time extension was authorized by the United States Army Corps of Engineers on 13 June 2022. The USFWS has provided documentation from the United States Army Corps of Engineers (SPK-2016-00524) authorizing in-water construction activities to continue until 22 December 2025.

The Certification is amended to reflect an updated expiration date of 22 December 2025.

APPLICATION FEE RECEIVED:

No fee was required for this amendment. Total fees of \$200.00 for the original Certification were received on 6 November 2017. The fee amount was determined as required by California Code of Regulations, title 23, sections 3383(b)(3) and 2200(a)(3), as was calculated as category D - Ecological Restoration and Enhancement Projects (fee code 85) with the dredge and fill fee calculator.
