### **ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY CONDITIONED WATER QUALITY CERTIFICATION; CALAVERAS COUNTY PUBLIC WORKS DEPARTMENT, MONGE RANCH ROAD BRIDGE REPLACEMENT PROJECT (WDID#5B05CR00089A1), CALAVERAS COUNTY**

This Order responds to the 14 March 2023 request for an amendment of the Monge Ranch Road Bridge Replacement Project (Project) Section 401 Water Quality Certification (WDID#5B05CR00089). The original Water Quality Certification (Certification) was issued on 01 June 2020. The requested amendment is hereby approved. The original Certification is therefore amended as described below. Please retain this document with the original Certification for your records.

#### **AMENDMENT:**

Calaveras County Public Works Department is requesting a time extension through 14 March 2026 to correspond with the updated expiration date of the U.S. Army Corps of Engineers 404 Permit (SPK-2020-00218). Calaveras County Public Works Department has provided documentation from the United States Army Corps of Engineers authorizing in-water construction activities to continue until 14 March 2026.

#### **APPLICATION FEE RECEIVED:**

No fee was required for this amendment. Total fees of \$1,949.00 for the original Certification were received on 3 April 2020. The fee amount was determined as required by California Code of Regulations, title 23, sections 3383(b)(3) and 2200(a)(3), as was calculated as category E - Low Impact Discharges (fee code 87) with the dredge and fill fee calculator.
