ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY CONDITIONED WATER QUALITY CERTIFICATION; DENOVA HOMES, SUMMER LAKE NORTH PROJECT (WDID#5B07CR00110A1), CONTRA COSTA COUNTY

This Order responds to the 4 October 2021 request for an amendment of the Summer Lake North Project (Project) Section 401 Water Quality Certification (WDID#5B07CR00110). The original Water Quality Certification (Certification) was issued on 3 May 2011. The requested amendment is hereby approved. The original Certification is therefore amended as described below. Please attach this document to the original Certification.

AMENDMENT:

Encore Capital Management purchased the Project from Shea Homes and sold it to DeNova Homes. Encore Capital Management is requesting a transfer of ownership to DeNova Homes and is also requesting a time extension through 1 August 2023. The name change will allow DeNova Homes to proceed with the Project described in the original Certification. A time extension was authorized by the United States Army Corps of Engineers on 9 June 2021.

DeNova Homes has provided documentation from the United States Army Corps of Engineers (SPK-2006-00962) authorizing in-water construction activities to continue until 1 August 2023.

APPLICATION FEE RECEIVED:

No fee was required for this amendment. Total fees of \$40,000.00 for the original Certification were received on 8 February 2010. The fee amount was determined as required by California Code of Regulations, title 23, sections 3383(b)(3) and 2200(a)(3), as was calculated as category A - Fill & Excavation Discharges (fee code 84) with the dredge and fill fee calculator.
