### **401 CERTIFICATION RE-AUTHORIZATION AND TIME EXTENSION REQUEST, COUNTY OF FRESNO, TRAVERS CREEK BRIDGE REPLACEMENT MANNING AVE, FRESNO COUNTY (WDID# 5B10CR00100A1)**

On 4 February 2021, the County of Fresno (Applicant) was issued a Federal Clean Water Act (CWA) Section 401 Water Quality Certification (Certification) by the Central Valley Regional Water Quality Control Board (Central Valley Water Board). The Certification authorizes impacts to waters of the United States or waters of the state as a result of activities for the Travers Creek Bridge Replacement on Manning Avenue (Project).

The Certification certified the Project which was permitted under 2021 Nationwide Permit No. 14 – Linear Transportation Projects issued by the United States Army Corps of Engineers (USACE). The USACE re-issued the 2021 Nationwide Permit 14 with some modifications, on 8 January 2026 with an effective date of 15 March 2026. The new 2026 Nationwide Permits will expire on 15 March 2031. The Central Valley Water Board has reviewed your Certification and hereby re-authorizes the Certification for the Project permitted under 2026 Nationwide Permit No. 14 as well as authorizes a time extension for the Certification to 15 March 2031. A new Certification application and applicable fees will be required for any Project activities that will occur after this new expiration date.
