### **ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY CONDITIONED WATER QUALITY CERTIFICATION; MADERA COUNTY PUBLIC WORKS DEPARTMENT, ROAD 200 FINE GOLD CREEK BRIDGE PROJECT (WDID NO. 5B20CR00090A1), MADERA COUNTY**

This Order responds to the 28 February 2022 request for an amendment of the Road 200 Fine Gold Creek Bridge (Project) Section 401 Water Quality Certification (WDID No. 5B20CR00090). The original Water Quality Certification (Certification) was issued on 30 May 2017. The requested amendment is hereby approved. The original Certification is therefore amended as described below. Please attach this document to the original Certification.

This amendment is not valid until and unless an amendment to the Section 404 Permit with equivalent modifications is approved by the United States Army Corps of Engineers (USACE) or it is otherwise determined by USACE that an amendment of the 404 Permit is unnecessary.

#### **AMENDMENT:**

Madera County Public Works Department is requesting a time extension through 17 March 2023. A time extension was authorized by the United States Army Corps of Engineers on 16 February 2022, and the California Department of Fish and Wildlife on 10 February 2022.

Madera County Public Works Department has provided documentation from the United States Army Corps of Engineers and the California Department of Fish and Wildlife (Streambed Alteration Agreement# 1600-2016-0224-R4) authorizing in-water construction activities to continue until 17 March 2023.

#### **APPLICATION FEE RECEIVED:**

No fee was required for this amendment. Total fees of \$2,807.00 for the original Certification were received on 4 January 2017. The fee amount was determined as required by California Code of Regulations, title 23, sections 3383(b)(3) and 2200(a)(3), as was calculated as category A - Fill & Excavation Discharges (fee code 84) with the dredge and fill fee calculator.
