ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY CONDITIONED WATER QUALITY CERTIFICATION; STONERIDGE QUARRY, LLC, STONERIDGE QUARRY PROJECT (WDID#5B34CR00050A2), SACRAMENTO COUNTY

This Order responds to the 1 March 2022 request for an amendment of the Stoneridge Quarry Project (Project) Section 401 Water Quality Certification (WDID#5B34CR00050). The original Water Quality Certification (Certification) was issued on 29 April 2016 and amended on 18 June 2018 (WDID#5B34CR00050A1). A time extension was granted on 16 July 2020. The requested second amendment is hereby approved. The original Certification is therefore amended as described below. Please attach this document to the original Certification.

AMENDMENT:

Stoneridge Quarry, LLC is requesting a time extension to coincide with the approved work period expiration received from the California Department of Fish and Wildlife. The Certification is hereby amended to extend the Certification expiration from 14 May 2023 to 14 May 2028.

APPLICATION FEE RECEIVED:

No fee was required for this amendment. Fees in the amount of \$944.00 for the original Certification fee were received on 22 May 2012. Additional fees for water quality impacts of \$42,290.00 were received on 21 March 2013. The fee amount was determined as required by California Code of Regulations, title 23, sections 3383(b)(3) and 2200(a)(3), as was calculated as category A - Fill & Excavation Discharges (fee code 84) with the dredge and fill fee calculator.
