ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY CONDITIONED WATER QUALITY CERTIFICATION; GREENLAW DEVELOPMENT LLC, MARIPOSA INDUSTRIAL PARK PROJECT (WDID#5B39CR00369A1), SAN JOAQUIN COUNTY

This Order responds to the 13 June 2023 request for an amendment of the Mariposa Industrial Park Project (Project) Section 401 Water Quality Certification (WDID#5B39CR00369). The original Water Quality Certification (Certification) was issued on 27 January 2023. The requested amendment is hereby approved. The original Certification is therefore amended as described below. Please attach this document to the original Certification.

AMENDMENT:

Greenlaw Development LLC is requesting an updated project description. Greenlaw Development LLC has provided documentation from the United States Army Corps of Engineers (SPK-2022-00080) authorizing in-water construction activities to continue until 26 January 2028.

The revised impact to waters of the U.S. is 0.47 acre (0.22 acre of stream channel and 0.25 acre of seasonal wetlands). This is an increase of impacts to an additional 0.22 acre of wetland habitat. Constructing the detention basin will involve excavating and filling a realigned tributary to North Littlejohns Creek and filling two seasonal wetlands. Excavated soil will be stockpiled and/or placed of in uplands in other parts of the site.

The Certification is amended to reflect an updated authorization for in-water construction activities. Table 1 in the Certification is amended as shown below:
