ORDER NO. R5-2010-0088

RESCINDING WASTE DISCHARGE REQUIREMENTS

The California Regional Water Quality Control Board, Central Valley Region, finds that the Board adopted the following Orders which are no longer applicable for the reasons shown:

- a) **Resolution No. 58-490** prescribes requirements for the discharge of oil field production wastewater to sumps operated by Allied Western Petroleum, LLC, on the Alferitz Lease in the NE ¼ of Section 14, T25S, R18E, MDB&M, Devils Den Oil Field, Kern County. A recent lease inspection by Central Valley Water Board staff confirmed that discharge to the sumps has been discontinued and the sumps closed. Produced wastewater is discharged to a Class II injection well in accordance with a permit issued by California Division of Oil, Gas, and Geothermal Resources. Therefore, it is appropriate to rescind Waste Discharge Requirements Order 58-490. (CDH)

- b) **Waste Discharge Requirements Order 81-097**, adopted on 25 September 1981, prescribes requirements for the discharge to land of wastewater from the United States Department of the Interior, National Park Service, Sequoia-Kings Canyon National Park's Buckeye Mountain Wastewater Treatment Facility (WWTF). The WWTF is about 5 miles northeast of the community of Three Rivers, adjacent to Generals Highway (Highway 198) and the Middle Fork of the Kaweah River in Section 4, T17S, R29E, MDB&M in Tulare County. As of 6 June 2010, the discharge is regulated under the State Water Resources Control Board Water Quality Order No. 97-10-DWQ, *General Waste Discharge Requirements for Discharges to Land by Small Domestic Wastewater Treatment Systems*. Therefore, it is appropriate to rescind Waste Discharge Requirements Order 81-097. (SJP)

- c) **Waste Discharge Requirements Order 81-098**, adopted on 25 September 1981, prescribes requirements for the discharge to land of wastewater from the United States Department of the Interior, National Park Service, Sequoia-Kings Canyon National Park's Ash Mountain Wastewater Treatment Facility (WWTF). The WWTF is about six miles northeast of the community of Three Rivers, adjacent to Generals Highway (Highway 198) and the Middle Fork of the Kaweah River in Section 34, T16S, R29E, MDB&M in Tulare County. As of 6 June 2010, the discharge is regulated under the State Water Resources Control Board Water Quality Order No. 97-10-DWQ, *General Waste Discharge Requirements for Discharges to Land by Small Domestic Wastewater Treatment Systems*. Therefore, it is appropriate to rescind Waste Discharge Requirements Order 81-098. (SJP)

IT IS HEREBY ORDERED that the above Waste Discharge Orders are rescinded.
