ORDER NO. R5-2011-0063

**RESCINDING NPDES/WDR RESCISSIONS**

- a) **WDRs Order No. 73-53** regulates discharge from the San Luis RV Resort. April Fry applied for coverage under Water Quality Order No. No. 97-10-DWQ, and Notice of Applicability was issued on 23 May 2011. WDRs Order No. 73-53 should be rescinded.
- b) **WDRs Order No. 79-072** regulates discharge from the Badger Pass Ski Area. The National Park Service applied for coverage under Water Quality Order No. No. 97-10-DWQ, and Notice of Applicability was issued on 24 May 2011. WDRs Order No. 79-072 should be rescinded.
- c) **WDRs Order No. 79-163** regulates discharge from the Tulare County Department of Education, SCICON. The Tulare County Office of Education applied for coverage under Water Quality Order No. No. 97-10-DWQ, and Notice of Applicability was issued on 15 June 2011. WDRs Order No. 79-163 should be rescinded.
- d) **WDRs Order No. 86-111** regulates discharge from the California Hot Springs Water and Sewer Company. The California Hot Springs Water Company applied for coverage under Water Quality Order No. No. 97-10-DWQ, and Notice of Applicability was issued on 23 May 2011. WDRs Order No. 86-111 should be rescinded.
- e) **WDRs Order No. 86-226** regulates discharge from the San Luis State Recreation Area/Basalt Camp. The California Department of Parks and Recreation applied for coverage under Water Quality Order No. No. 97-10-DWQ, and Notice of Applicability was issued on 17 June 2011. WDRs Order No. 86-226 should be rescinded.
- f) **WDRs Order No. 89-248** regulates discharge from the Dodge Ridge Ski Area. The Dodge Ridge Corporation applied for coverage under Water Quality Order No. No. 97-10-DWQ, and Notice of Applicability was issued on 15 June 2011. WDRs Order No. 89-248 should be rescinded.
- g) **WDRs Order No. 91-014** regulates discharge from the Baseline Conservation Camp. The Department of Forestry and Fire Protection applied for coverage under Water Quality Order No. No. 97-10-DWQ, and Notice of Applicability was issued on 16 June 2011. WDRs Order No. 91-014 should be rescinded.
- h) **WDRs Order No. 91-189** regulates discharge from the Hetch Hetchy Water and Power, O'shaughnessy Wastewater Treatment Facility Yosemite National Park. The City and County of San Francisco applied for coverage under Water Quality Order No. No. 97-10-DWQ, and Notice of Applicability was issued on 15 June 2011. WDRs Order No. 91-189 should be rescinded.

- i) **WDRs Order No. 93-062** regulates discharge from the Yosemite National Park, White Wolf Campground. The Park Service applied for coverage under Water Quality Order. 97-10-DWQ, and Notice of Applicability was issued on 6 June 2011. WDRs Order No. 93-062 should be rescinded. (WDH)
- j) **Waste Discharge Requirements (WDRs) Order No. 93-064** was adopted on 21 May 1993, prescribes requirements for the operation of a placer gold mine (Carr Mine) in Butte County. The mine was subject to numerous enforcement actions including issuance of a Cleanup and Abatement Order and Administrative Civil Liability for failure to comply with the WDRs. On July 18, 1994, the Butte County Superior Court issued a restraining order shutting down all mining operations. No mining activity has been conducted since that time. The owners abandoned the site and failed to reclaim the property as required by the county. The county obtained the reclamation bond and stabilize the site against erosion. Subsequently the mine has changed ownership. If the current owner plans to resume mining operations, a new Report of Waste Discharge will be required.
- k) **WDRs Order No. 94-105** regulates discharge from the Courtright Lake Village Mutual Water Company. The Courtright Lake Village Mutual Water Company applied for coverage under Water Quality Order No. No. 97-10-DWQ, and Notice of Applicability was issued on 16 June 2011. WDRs Order No. 94-105 should be rescinded.
- l) **WDRs Order No. 94-255** regulates discharge from the McClure Boat Club Trailer Park, Wastewater Treatment Facility. The Lake McClure Boat Club, Inc. applied for coverage under Water Quality Order No. No. 97-10-DWQ, and Notice of Applicability was issued on 28 June 2011. WDRs Order No. 94-255 should be rescinded.
- m) **WDRs Order No. 94-358** regulates discharge from the Leland Meadow Water District. The Leland Meadow Water District applied for coverage under Water Quality Order No. No. 97-10-DWQ, and Notice of Applicability was issued on 16 June 2011. WDRs Order No. 94-358 should be rescinded.
- n) **WDRs Order No. 96-214** regulates discharge from the Mount Bullion Youth Conservation Camp. The Department of Forestry and Fire Protection applied for coverage under Water Quality Order No. No. 97-10-DWQ, and Notice of Applicability was issued on 16 June 2011. WDRs Order No. 96-214 should be rescinded.
- o) **Waste Discharge Requirements (WDRs) Order No. 5-00-204** was issued to Spanish Flat Enterprises, Inc. to regulate the discharge of domestic wastewater from the Spanish Flat Resort on the shore of Lake Berryessa in Napa County. Domestic wastewater was discharged from septic tanks to an evaporation-percolation pond. The resort was closed in 2009 and all of the on-site improvements were demolished by the property owner, United States Department of Interior, Bureau of Reclamation (Reclamation). A final facility closure report documenting the removal of the septic tanks, evaporation-percolation pond, and sewer system was submitted on 24 January 2011. In a letter received on 11 May 2011, Reclamation requested rescission of WDRs Order No. 5-00-204. Because the discharge has ceased and the wastewater treatment facility has been permanently closed, WDRs Order No. 5-00-204 is no longer necessary.

- p) **Waste Discharge Requirements (WDRs) Order No. 5-01-202** was adopted on 27 July 2001 for the construction and closure of the Stowell Waste Rock Containment Facility in Shasta County. The waste rock was from the historic operation of the Stowell Mine and contributed to the heavy metal loading in Spring Creek upstream of Iron Mountain Mine. The lined facility has been capped with a synthetic liner and erosion resistant layer. Post-closure monitoring for the past 10 years has revealed no leachate being generated and minimal maintenance is necessary. Continued post-closure monitoring, beyond annual inspections for damage to the erosion resistant cover, is unnecessary
- q) **In 2002, the Regional Water Quality Control Board, Central Valley Region adopted Order No. R5-2002-0130 (NPDES Permit No. CA0083925)** allowing the Riviera West Mutual Water Company (Discharger) to discharge wastewater into Clear Lake. The NPDES Permit requires the Discharger to file a Report of Waste Discharge (RoWD), no later than 180 days prior to the 1 July 2007 permit expiration date, for permit renewal if the Discharger chooses to continue the surface water discharge. As of October 2008, the Discharger has ceased surface water discharge in accordance with the NPDES Permit and began land applying the wastewater. On 29 December 2008, and through additional submittals, the Discharger filed a RoWD for Waste Discharge Requirements for its application of wastewater to land. Therefore, the NPDES permit is being rescinded.
- r) **Waste Discharge Requirements (WDRs) Order R5-2004-0110 (NPDES Permit No. CA0080799)**, adopted on 10 September 2004, regulates the discharge of settled filter backwash water from the Bella Vista Water District's (Discharger) drinking water treatment plant in Shasta County. The discharge is to Dry Gulch, a water of the U.S. The Discharger has modified its facility to recycle the filter backwash water, and no longer discharges to waters of the U.S. Therefore the subject WDRs are no longer needed.

IT IS HEREBY ORDERED that the above NPDES and WDR orders are rescinded.
