**ORDER R5-2025-0065**

**RESCINDING WASTE DISCHARGE REQUIREMENTS**

The California Regional Water Quality Control Board, Central Valley Region (Central Valley Water Board), finds that the Central Valley Water Board previously adopted the following Orders which are no longer applicable for the reasons shown:

**A. INDIAN VALLEY COMMUNITY SERVICES DISTRICT, GREENVILLE  
WASTEWATER PONDS, PLUMAS COUNTY – WASTE DISCHARGE  
REQUIREMENTS ORDER NO. 99-046**

The California Regional Water Quality Control Board, Central Valley Region (Central Valley Water Board), finds that the Central Valley Water Board adopted the following Order which is no longer applicable for the reasons shown:

Waste Discharge Requirements (WDR) Order 99-046, adopted on 30 April 1999, was issued to Indian Valley Community Services District (Discharger) and prescribes requirements for a waste discharge from the community of Greenville to five wastewater stabilization ponds covering approximately 28 acres (Facility). Wastewater receives no treatment before entering the first pond. Historically, the Facility discharged approximately 192,500 gallons of wastewater per day and maintained 570 service connections. Wastewater flows have been greatly reduced since the 2021 Dixie Fire, therefore an individual WDR Order is no longer necessary. A recent survey conducted by the Discharger showed there are 159 active connections, and average daily flows are 50,000 gallons per day. Based on current conditions, the Facility treats and disposes of less than 100,000 gallons of wastewater per day and is therefore eligible for coverage under the general and specific conditions of State Water Resources Control Board (State Water Board) Water Quality Order 2014-0153-DWQ General Waste Discharge Requirements for Small Domestic Wastewater Treatment Systems (General Order). On 16 September 2025, the Facility was enrolled under General Order 2014-0153-DWQ-R5428. Therefore, it is appropriate to rescind Waste Discharge Requirements Order 99-046.

**B. MICHAEL FOWLER, WATER RECYCLING PROJECT, LAKE COUNTY,  
WASTE DISCHARGE REQUIREMENTS ORDER NO. 99-070**

Waste Discharge Requirements Order No. 99-070, adopted on 11 June 1999, prescribes requirements for the discharge of recycled water – specifically disinfected secondary treated effluent - from the Kelseyville County Water Works, District No. 3 Wastewater Treatment Facility to a 5-acre vineyard owned and operated by Michael Fowler (hereafter referred to as the Discharger). The vineyard, designated as the Water Recycling Area, is located on Accessor Parcel Nos. (APN) 009-003-09 and 009-003-19 in Lake County. Order No. 99-070 authorizes the use of up to 5 million gallons of

recycled water annually for irrigation of the Water Recycling Area. The Discharger is no longer accepting recycled water at the property. Given the cessation of recycled water use at the site, it is appropriate to rescind Waste Discharge Requirements Order No. 99-070.

IT IS HEREBY ORDERED that the above Orders are rescinded on the date of this order unless otherwise stated above.
