NOTICE OF APPLICABILITY; CENTRAL VALLEY WATER BOARD RESOLUTION R5-2023-0061; WAIVER OF WASTE DISCHARGE REQUIREMENTS, REPORTS OF WASTE DISCHARGE, AND/OR WATER RECYCLING REQUIREMENTS FOR SPECIFIC TYPES OF DISCHARGE WITHIN THE CENTRAL VALLEY REGION; SUPERIOR MUTUAL WATER COMPANY; WELL 3 GAC TREATMENT PLANT BACKWASH; KERN COUNTY

On 14 December 2023, the Central Valley Water Board adopted Resolution R5-2023-0061, *Waiver of Waste Discharge Requirements, Reports of Waste Discharge, and/or Water Recycling Requirements for Specific Types of Discharge Within the Central Valley Region* (Low Threat Waiver), which renewed Resolution R5-2018-0085. On 9 August 2023, the Superior Mutual Water Company (Discharger) was issued Notice of Applicability (NOA) R5-2018-0085-0085 for the discharge of backwash water from a granular activated carbon (GAC) treatment system used to remove 1,2,3-trichloropropane (or 1,2,3-TCP).

The Low Threat Waiver requires existing dischargers subject to a NOA issued on or after 1 January 2023, to submit written affirmation of its intent to comply with the general conditions, discharge-specific conditions, and exclusions specified by the Low Threat Waiver no later than 15 March 2024. The Discharger submitted a letter on 26 January 2024 to comply with the Low Threat Waiver. The Discharger is hereby assigned enrollee number **R5-2023-0061-0012** and shall comply with the NOA, Monitoring and Reporting Program R5-2018-0085-0085, and general conditions, discharge-specific conditions, and exclusions specified by the 2023 Low Threat Waiver.
