**AGENDA ITEM: 11**

**SUBJECT:**

Following are proposed Waste Discharge Requirements Orders that prohibit discharge to surface waters. All agencies and the dischargers concur or have offered no comments. Items indicated as updates on the summary agenda make the requirements consistent with current plans and policies of the Board.

**BOARD ACTION:**

Consideration of Waste Discharge Requirements

**BACKGROUND:**

**a. All State Packers, Inc., Rivermaid Trading Company Fruit Processing Facility, San Joaquin County**

Rivermaid Trading Company, established in 1979 and located in Lodi, California, processes cherries and pears. Activities include receiving, cleaning, chilling, cold storage of the fruit, and fumigation, for distribution to wholesalers and assembly of fruit baskets and packages.

The wastewater treatment system consists of screens, an unlined wastewater pond, and newly constructed land application areas (LAAs). Wastewater quality in the pond is considered good quality as it is similar in quality to the source water used at the Facility.

There are no groundwater monitoring wells located onsite. Depth to groundwater beneath the facility ranges from 80 to 100 feet below ground surface. Potential groundwater impacts from discharges to land from this facility are expected to be negligible.

**RECOMMENDATION:**

Adopt the proposed Waste Discharge Requirements.

**b. Triangle Rock Products, Inc., Florin Road Aggregate Plant, Sacramento County, –Consideration of Amended Waste Discharge Requirements R5-2011-0028**

Triangle Rock Products, Inc owns and operates the Florin Road Aggregate Plant located at 11501 Florin Road in Sacramento County. The Plant has been operating since the late 1990's. Order R5-2011-0028, adopted by the Central Valley Water Board on 8 April 2011, allows mining of sand and gravel on two parcels (the original mining area identified by APN 067-0120-069 and the Expansion Area identified by APN 067-0120-074) and waste discharges from the aggregate washing operations within the original mining area. Mining operations involve Phases I – X at APN 067-0120-069 and Phases E-1, E-2, and E-3 at APN 067-0120-074. Phases I – IX are complete. Phase X contains the existing processing plant and settling ponds. Mining of APN 067-0120-074 began in 2013 and is currently in progress.

The Discharger is requesting to allow surface mining on an additional parcel referred to as the Carli Expansion Area and identified by APN 067-0120-073. The new area is bordered to the north and east by APN 067-0120-069. Mining of sand and gravel will occur on approximately 140 acres of the 161-acre parcel. Proposed mining depth is approximately 60 to 65 feet below ground surface. Mining operations at the Carli Expansion Area will occur in two phases (T-1 and T-2), to allow current tenants (a composting facility and cell tower) to remain onsite while mining progresses around them. No aggregate washing operations or land discharges of aggregate process wastewater will occur at the Carli Expansion Area. All aggregate materials from the Carli Expansion Area will be transported to the existing processing plant located at APN 067-0120-069.

Board staff proposes to amend the WDRs to allow surface mining at the Carli Expansion Area. Attachments A and B of the WDRs will be amended to show the approximate location of the additional parcel. No changes to the Monitoring and Reporting Program are proposed at this time. There are no outstanding issues.

**RECOMMENDATION:**

Adopt the Order amending WDRs for the Florin Road Aggregate Plant.
