NOTICE OF PUBLIC HEARING

**TENTATIVE AMENDING WASTE DISCHARGE REQUIREMENTS
for
TRIANGLE ROCK PRODUCTS, INC
FLORIN ROAD AGGREGATE FACILITY
SACRAMENTO COUNTY**

Triangle Rock Products, Inc (hereafter referred to as Discharger) owns and operates the Florin Road Aggregate Plant (Facility) located at 11501 Florin Road in Sacramento County. The Facility is currently regulated by Waste Discharge Requirements (WDRs) R5-2011-0028. The Discharger is proposing to surface mine an additional parcel (Assessor Parcel Number 067-0120-073, also referred to as the Carli Expansion Area) which is bordered to the north and east by the Facility, to the south by Florin Road, and to the west by Eagle Nest Road. Tentative Amending Order R5-2021-XXXX amends WDRs Order R5-2011-0028, allowing surface mining of the additional parcel.
