TO ALL CONCERNED PERSONS AND AGENCIES:

The proposed tentative Waste Discharge Requirements Order for the City of Turlock and City of Modesto (Discharger), combined discharge from the City of Turlock Regional Water Quality Control Facility and the City of Modesto Water Quality Control Facility to the Delta-Mendota Canal via the North Valley Regional Recycled Water Program Joint Outfall, is available for public review and comment. In accordance with the Notice of Public Hearing, written comments and evidence concerning the proposed Order must be submitted to this office no later than 5:00 p.m. on **5 May 2022**. Written material submitted after 5:00 p.m. on **5 May 2022** will not be accepted and incorporated into the administrative record absent a ruling by the Board Chair.

A Public Hearing has been scheduled for the Central Valley Regional Water Quality Control Board (Central Valley Water Board) to consider adoption of the proposed Order at its **9/10 June 2022** Board Meeting. See the enclosed Notice of Public Hearing for additional information about the Public Hearing. The Discharger must post one (1) copy of the Notice of Public Hearing at the nearest city hall or county courthouse, one (1) copy at the post office nearest to the Facility (if allowed), and one (1) copy at the public entrance to the Facility. Please post the Notice as soon as possible and provide proof of posting, using the enclosed form, by **19 April 2022**.
