The Central Valley Regional Water Quality Control Board (Central Valley Water Board) will be considering adoption of a tentative Waste Discharge Requirements Order (Order) for fill discharges to waters deemed by the U.S. Army Corps of Engineers to be outside of federal jurisdiction for the EDP Renewables CA Solar Park LLC, Sandrini Solar Project (Project). The Central Valley Water Board is currently soliciting public comments on the tentative Order in accordance with the enclosed Notice of Public Hearing.
