NOTICE OF PUBLIC HEARING

EVERGREEN SIERRA EAST, LLC
COLLEGE PARK, SITE A PROJECT
PLACER COUNTY

A tentative Waste Discharge Requirements Order (Order) is proposed for the Evergreen Sierra East, LLC (Permittee), College Park, Site A Project (Project) in Placer County. The approximately 59-acre Project consists of mass grading for future development, including the construction of 326 single family homes, 99 multi-family units, and a Community Clubhouse on 40.4 acres of developed area, 8.9 acres of open space, and 6.3 acres of parks.

The tentative Order provides details of the Project activities, including compensatory mitigation measures planned to compensate for the permanent loss of 0.412 acre of aquatic resources (0.082-acre riparian wetland, 0.087-acre seasonal wetland, 0.089-acre seasonal wetland swale, 0.119-acre seep, and 0.035-acre ephemeral drainage) and requiring avoidance and minimization measures to reduce on-site impacts during construction activities. The tentative Order describes technical conditions required to be met throughout the implementation of construction activities to ensure activities meet Basin Plan and other regulatory requirements.

The designated parties for this hearing are as follows:

Only designated parties will have these rights: to call and examine witnesses; to introduce exhibits; to cross-examine opposing witnesses; to impeach any witness; and to rebut the evidence against him or her. Interested persons may not cross examine witnesses and will not be subject to cross examination. Interested persons may submit evidence (e.g., photographs, eye-witness testimony, monitoring data) if the evidence is submitted in accordance with the deadlines for submitting evidence described below. Interested persons who present evidence may be subject to cross-examination. Interested persons may request status as a designated party for purposes of this hearing by submitting such request in writing to the Board **no later than 5 p.m on 1 July 2023**. The request must explain the basis for status as a designated party and in particular how the person is affected by the discharge.

Persons wishing to comment on this item must submit testimony, evidence, if any, and/or comments in writing to the Central Valley Water Board via email to stephanie.tadlock@waterboards.ca.gov **no later than by 5:00 p.m. on 14 July 2023**. Written materials submitted after 5:00 p.m. on the above date will not be accepted and will not be incorporated into the administrative record absent a ruling by the Board Chair. Any party requesting to submit late materials must demonstrate good cause for the late submission, and the Chair must find that the late submission would not prejudice the Central Valley Water Board or any designated party.

All designated parties and interested persons may speak at the Central Valley Water Board meeting and are expected to orally summarize their written submittals. Oral testimony and cross examination will be limited in time by the Board Chair.
