CENTRAL VALLEY REGIONAL WATER QUALITY CONTROL BOARD'S PYRETHROID RESEARCH PLAN

NOTICE IS HEREBY GIVEN THAT the California Regional Water Quality Control Board, Central Valley Region (Central Valley Water Board) will hold a virtual staff workshop to discuss the revisions made to the Central Valley Water Board's draft Pyrethroid Research Plan following the public comment period that ended in September 2023. The workshop will consist of an open discussion where Board staff will answer attendee questions pertaining to the Pyrethroid Research Plan.

The Central Valley Water Board's Pyrethroid Research Plan is a deliverable of the Amendment of the Water Quality Control Plan for the Sacramento River and San Joaquin River Basins for the Control of Pyrethroid Pesticide Discharges (Pyrethroid Control Program, R5-2017-0057). The Pyrethroid Control Program has been effective since 19 February 2019. The Pyrethroid Research Plan summarizes the current state of science, and identifies research and special studies that, once completed, may inform future iterations of pyrethroid pesticide discharge regulations.
