TENTATIVE CEASE AND DESIST ORDER INFORMATION

The City of Alturas (Discharger) is the owner and operator of the City of Alturas Wastewater Treatment Plant (Facility), located at 20099 County Road 54, Alturas, California. The Facility provides sewerage service for the City of Alturas, serving a population of approximately 2,500. The Facility discharges secondary-treated wastewater to the Pit River, a water of the United States.

Discharges from the Facility are currently regulated by Waste Discharge Requirements Order R5-2020-0004 (NPDES Permit) and Cease and Desist Order (CDO) R5-2020-0005, issued by the Central Valley Regional Water Quality Control Board (Central Valley Water Board) on 20 February 2020. The NPDES Permit contains effluent limitations for aluminum. CDO R5-2020-0005 contains a compliance schedule that expired on 31 March 2025. The Discharger has made diligent efforts to comply with the final effluent limitations for aluminum but has demonstrated that additional time is needed to comply. Therefore, a Cease and Desist Order is proposed to allow additional time for compliance with these final effluent limitations until 31 March 2030.

COMMENT PERIOD

Persons wishing to comment in writing on the proposed Cease and Desist Order must submit such comments no later than 5:00 p.m. on **16 January 2026** to the Central Valley Water Board email at RB5S-NPDES-Comments@waterboards.ca.gov. The Board may refuse to admit untimely written materials and shall refuse to do so when there is a showing of prejudice to the Discharger or the Board. Excluded material will not be considered.
