Opportunities to Comment

The Central Valley Water Board will consider oral and written comments on the proposed Order before it votes on whether to adopt the Order.

Written comments or evidence concerning the Order must be submitted by 5:00 pm on 27 April 2026. The Board Chair may refuse to admit any comments or evidence received after the comment period unless the submitting party provides a reasonable explanation for why the submission is late and the Board Chair determines that admission of the late submission would not prejudice any other party.

Oral comments concerning the Order must be presented at the scheduled public meeting. Interested parties are generally allowed up to three minutes each to provide their comments. Certain **designated parties** may provide longer comments and have the right to call and examine witnesses, introduce exhibits, cross-examine opposing witnesses, impeach any witness, and to rebut the evidence against him or her. The parties subject to the proposed Order are designated parties. Any other party may request recognition as a designated party by submitting a written statement of how they are directly affected by the discharge(s) to be regulated and why they would like to be considered a designated party. Such requests must be submitted to Central Valley Water Board no later than **5:00 p.m. on 26 April 2026**. Instructions on how to provide oral comments will be included in the Final Agenda for the meeting.

Proposed Order

If adopted, Waste Discharge Requirements (WDRs) Order R5-20XX-XXXX will prescribe continued monitoring, post-closure maintenance and corrective action requirements for the Chateau Fresno Municipal Solid Waste Landfill, located at 8662 W. Muscat Ave, Fresno, CA. Browning-Ferris Industries of California, Inc. (hereafter referred to as Discharger) own and maintain the Chateau Fresno Municipal Solid Waste

Landfill. The Discharger will be responsible for maintaining compliance with Order requirements. The Facility is currently regulated under WDR Order R5-2018-0082. If adopted, the proposed WDRs Order R5-2026-XXXX will rescind and replace the previous WDRs Order.
