### PUBLIC NOTICE: CLEANUP PROGRAM SITE CASE

## 442 B Street (T10000021372) 442 B STREET, YUBA CITY, SUTTER COUNTY

Central Valley Water Board staff (Staff) has opened a Cleanup Program Site (SCP) case for the discharge of metals, pesticides, herbicides, and petroleum at this currently vacant property. The City of Yuba City (Yuba City) is continuing to investigate these discharges. This property has been vacant since 1990. In the past, the property was used for chemical storage, fruit packing/canning, and maintenance of freight trucks. A map showing the location of this property is provided at the end of this notice.

Yuba City's investigation of this property is being funded by an Equitable Community Revitalization Grant (ECRG) administered by the Department of Toxic Substances Control's (DTSCs) Office of Brownfields. Staff is working cooperatively with Yuba City, DTSC, and Yuba City's environmental consultant, EKI Environment & Water, Inc. (EKI), to test soil and groundwater at the property to determine the extent of the contaminants discharged to the property. Once the extent of the contamination has been determined, Yuba City and EKI will develop a plan to cleanup the property and return it to beneficial use for the community.

EKI is currently working to propose investigation field work necessary to test soil and groundwater at the property. EKI anticipates beginning investigation field work in November 2024. EKI anticipates completing this work in June 2025. Additional cleanup field work will follow. The start date of cleanup field work has not yet been determined.

Central Valley Water Board staff is providing this notice to inform the community surrounding the property that a SCP case has been opened and that activity on the property will increase with the start of the investigation field work. Yuba City will provide additional public notices regarding the property as work progresses. Please call or email the Central Valley Water Board contact listed on this notice if:
