PUBLIC NOTICE: PROPOSED PETROLEUM UNDERGROUND STORAGE TANK CASE CLOSURE

PUBLIC COMMENT PERIOD: 15 February through 17 April 2025

NOMELLINI PROPERTY; 1045 WEST CHARTER WAY, STOCKTON, SAN JOAQUIN COUNTY; GLOBAL ID #T0607700221

The Central Valley Regional Water Quality Control Board (Central Valley Water Board) invites public comment on the proposed case closure of the Nomellini Property leaking underground storage tank (tank) case, located at 1045 West Charter Way in Stockton, CA (property). A map showing the location is attached as Figure 1.

In August 1988, the property owner removed three underground storage tanks (tanks) from the property. Soil samples collected beneath the tanks contained petroleum, indicating an unauthorized release of petroleum had occurred at the property. The property owner conducted additional investigations in May 1989 to assess the extent of petroleum contamination in soil and to determine if the release had contaminated groundwater. Between February 1991 and May 2023, multiple investigations were performed to assess the extent of petroleum contamination in soil and groundwater.

The property owner's consultant working on this project has concluded that petroleum remaining in the ground does not pose a significant threat to human health, the environment, or future property activities. The remaining petroleum in soil and groundwater will naturally break down within a reasonable amount of time. The consultant recommended case closure under California's Low-Threat Closure Policy. Central Valley Water Board staff will consider public comments during case closure review.
