The widening along Sperry Avenue is approximately 14 to 18 feet on each side. However, additional widening is necessary at the approaches to the ramp intersections. Excavation will be required to construct the pavement structural sections and retaining walls needed to facilitate the roadway widening under the freeway. Existing tall embankment slopes will need to be widened along Sperry Avenue east of the interchange. The project proposes to replace the current 2-way stop control at the northbound on- I off-ramp intersection and the current 4-way stop control at the southbound on- / off-ramp intersection with signal control.
