**REVISED NOTICE OF PUBLIC HEARING
FOR
GENERAL WASTE DISCHARGE REQUIREMENTS FOR DISCHARGES OF WASTE
FROM IRRIGATED AGRICULTURAL LANDS FOR DISCHARGERS THAT ARE
MEMBERS OF A COALITION GROUP IN THE COACHELLA VALLEY, RIVERSIDE
COUNTY
TENTATIVE ORDER R7-2020-0026**

Staff of the California Regional Water Quality Control Board, Colorado River Basin Region (Colorado River Basin Water Board) has prepared tentative Order R7-2020-0026, *General Waste Discharge Requirements for Discharges of Waste from Irrigated Lands for Dischargers that are Members of a Coalition Group in the Coachella Valley* (Tentative Order).

The Tentative Order proposes to regulate owners and/or operators of irrigated agricultural lands (Dischargers) in Coachella Valley with the potential to discharge waste that may impact the quality of the waters of the state. The Tentative Order also establishes substantive and procedural requirements for third-party representatives of the Dischargers formed to assist with compliance with the order (Coalition Groups).

PUBLIC WORKSHOP

The Colorado River Basin Water Board held a public workshop on July 9, 2020 to discuss and solicit input on the Tentative Order. Staff provided an overview of key proposed order provisions and updates, including those relating to precedential requirements from State Water Resources Control Board (State Water Board) Order WQ 2018-0002, *In the Matter of Review of Waste Discharge Requirements General Order No. R5-2012-0116 for Growers Within the Eastern San Joaquin River Watershed that are Members of the Third-Party Group* (Eastern San Joaquin Order). After the staff presentation, there were comments from stakeholders and members of the public.

SUBMISSION OF WRITTEN COMMENTS

The Colorado River Basin Water Board accepted written comments regarding the Tentative Order during a sixty-day public comment period, which began **June 26, 2020** and ended **August 25, 2020**. Persons wishing to submit written comments on the Tentative Order were requested to do so as soon as possible, but no later than **August 25, 2020**.

The Colorado River Basin Water Board has implemented an electronic records management system to reduce paper consumption and improve overall accessibility to records and documents. EXPARTE COMMUNICATIONS

Ex parte communications are allowed in this matter subject to the disclosure requirements of Water Code section 13287. Please be advised that ex parte communications are prohibited for a period beginning 14 days before the Board meeting at which the Tentative Order is scheduled for Board action. For communications concerning any issue in this proceeding, ex parte communications are prohibited starting on **August 20, 2020**. If the Colorado River Basin Water Board does not take action on **November 12, 2020 (REVISED)**, the ex parte prohibition

will remain in place until the Board, the Chair, or the Executive Officer directs otherwise. Once lifted, the prohibition on ex parte communications may be reinstated for 14 days before the day of the Board meeting to which the decision is continued. The Board will provide notice if the prohibition is lifted and/or reinstated.
