The California Regional Water Quality Control Board, Colorado River Basin Region (Colorado River Basin Water Board) is releasing for public review and comment proposed Order R7-2021-0004 (Proposed Order) to the ORNI 33, LLC (Permittee) for the Wister Solar Energy Facility Project (Project). The Project site is located within northern Imperial County, California, approximately two miles northeast of the unincorporated town Niland, approximately five miles east of the Salton Sea, and 0.5 mile southwest of the Coachella Canal. The Project is expected to impact waters of the state.

The Colorado River Basin Water Board intends to consider adopting the Proposed Order during a public hearing that will commence at the time and place indicated:
