**NOTICE OF PUBLIC HEARING
FOR
WASTE DISCHARGE REQUIREMENTS
PROPOSED ORDER R7-2021-0013**

The California Regional Water Quality Control Board, Colorado River Basin Region (Regional Water Board) has prepared proposed Order R7-2021-0013 (Proposed Order) for Palm Springs Aerial Tramway, Valley Station Wastewater Treatment Facility (Facility), owned and operated by Mt. San Jacinto Winter Park Authority, located in the Palm Springs, Riverside County. The Regional Water Board intends to consider adopting the Proposed Order during a public hearing that will commence at the time and place indicated:

Time: 9:00 a.m.
Location: Virtual Meeting via Zoom Video and Teleconference

As a result of the COVID-19 emergency and the Governor's Executive Orders to protect public health by limiting public gatherings and requiring social distancing, the April 13, 2021 Board meeting will occur solely via remote presence. SUBMISSION OF WRITTEN COMMENTS

The Regional Water Board will accept written comments regarding the Proposed Order during a 30-day public comment period, which begins **February 26, 2021** and ends **March 29, 2021**. Persons wishing to submit written comments on the Proposed Order are requested to do so as soon as possible, but no later than **March 29, 2021**.

The Regional Water Board has implemented an electronic records management system to reduce paper consumption and improve overall accessibility to records and documents. HEARING PROCEDURE

Affected stakeholders and other interested persons are invited to attend and express their views orally on this matter at the public hearing. The Regional Water Board requests that those persons wishing to speak at the hearing provide a copy of their oral comments in writing before or during the hearing to ensure accuracy of the record.

Those who wish to speak at the hearing will be asked to fill out a virtual speaker request card and provide it to Regional Water Board staff prior to the meeting; information on filling out the virtual speaker card can be found on the Regional Water Board’s [website](#). Comments from the public will be limited to three (3) minutes per person. Any person planning to make a presentation to the Regional Water Board that requires the use of visual aids (such as overheads, slides, or video projector) should contact the assigned staff person to make arrangements before the meeting date in order to avoid unnecessary delays during the meeting. Where speakers can be grouped by affiliation or interest, such groups will be expected to select a spokesperson and not be repetitive.
