NOTICE OF OPPORTUNITY TO COMMENT

**PROPOSED RESOLUTION OF VIOLATIONS
CONDITIONAL SETTLEMENT OFFER NO. R7-2026-0004 FOR
NILAND COUNTY SANITATION DISTRICT, OWNER/OPERATOR
NILAND WASTEWATER TREATMENT PLANT
IMPERIAL COUNTY**

NOTICE IS HEREBY GIVEN THAT the California Regional Water Quality Control Board, Colorado River Basin Region (Colorado River Basin Water Board) is releasing for public comment a proposed resolution of discharge limit violations subject to mandatory minimum penalties pursuant to California Water Code (Water Code) section 13385, subdivisions (h) and (i).

On April 17, 2026, the Assistant Executive Officer of the Colorado River Basin Water Board issued Conditional Settlement Offer No. R7-2026-0004 to Niland County Sanitation District, Owner/Operator of Niland Wastewater Treatment Plant (Discharger), to resolve effluent limit violations of Waste Discharge Requirements Order No. R7-2025-0017 (NPDES No. CA0104451) without a formal enforcement proceeding.

On July 21, 2026, the Discharger accepted the Conditional Settlement Offer by signing the "Acceptance of Conditional Resolution and Waiver of Right to Hearing" (Acceptance and Waiver) and agreed to pay \$15,000 in mandatory minimum penalties and to waive its right to a hearing. Pursuant to federal regulations, the Colorado River Basin Water Board is releasing the Conditional Settlement Offer for public comment.

If no comments are received within thirty (30) days and no new material facts become available, the Executive Officer will execute the Acceptance and Waiver as a stipulated Order assessing the uncontested mandatory minimum penalty amount pursuant to Water Code sections 13385 and/or 13385.1. If, however, significant comments are received in opposition to the Conditional Settlement Offer, the offer may be withdrawn.

SUBMISSION OF WRITTEN COMMENTS

The Colorado River Basin Water Board will accept written comments regarding the Conditional Settlement Offer during a 30-day public comment period, which begins **July 29, 2026** and ends **August 28, 2026**. Persons wishing to submit written comments on the Conditional Settlement Offer are requested to do so as soon as possible, but no later than **5:00 p.m., August 28, 2026**.
