NOTICE OF COMPLIANCE ORDER NO. 02_18_22R_007_A1 REPLACE ADMINISTRATOR

This letter is to amend Compliance Order No. 02_18_22R_007 ("Order") issued to the Six Acres Water Company ("Company") public water system on October 10, 2022, by the State Water Resources Control Board (State Water Board).

Order No. 02_18_22R_007_A1 amends and supplements Compliance Order No. 02_18_22R_007 as follows:

1. The following is added as the final paragraph to the section entitled "Statement of Facts":

On April 10, 2024, Marlene Demery, Principal of Demery and Associates, emailed the State Water Boards and requested to be replaced as an Administrator.

On May 31, 2024, Marlene Demery communicated to the Board for Six Acres Water Company that Demery and Associates would like to resign and withdraw as an Administrator effective August 30, 2024.

On August 2, 2024, the State Water Board notified the Six Acres Water Company community of the selected Administrator. A public hearing was held

on September 18, 2024 and the community was provided with an opportunity to comment by September 26, 2024.

2. The following is added as the final paragraph to the section entitled "Findings":

Pursuant to section 116686(g) of the California Health and Safety Code, "the state board shall develop standards, terms, and procedures in a handbook adopted consistent with the process provided for in subdivision (a) of section 116760.43."

The 2023 Administrator Policy Handbook, section XII(C) states that "The State Water Board may remove an Administrator at any time."

The 2023 Administrator Policy Handbook, section XIII(A) outlines the steps to select an Administrator, including providing reasonable notice to the community with the name and qualifications of the Administrator, scope of the appointment, and disclosure of any conflicts of interest. There is an opportunity for the community to comment on the appointment within 30 days. The notice and public comment period may be provided as part of the public hearing process required by California Health and Safety Code, Section 116686.

The State Water Boards has determined that it is appropriate to appoint a new administrator because Demery and Associates expressed an interest in withdrawing as the administrator on May 31, 2024 and resigned on August 30, 2024. The State Water Boards appointed a new administrator as soon as practical to resume full scope administrator duties in accordance with California Health and Safety Code section 116686 and the 2023 Administrator Policy Handbook on behalf of the community for the designated water system, Six Acres Water Company.

As of October 1, 2024, SRT Consultants is appointed as the full scope administrator on behalf of the community for the designated water system, Six Acres Water Company, and Demery and Associates is terminated.

3. The following replaces Directive 1 of the section entitled "Order":

"Effective October 1, 2024, Six Acres Water Company is ordered to unconditionally accept administrative, technical, operational, legal, financial, and managerial services, including full management and control of all aspects of the Company, from SRT Consultants."

Except as amended herein, all other terms of Compliance Order No. 02_18_22R_007 shall remain in effect.

By **October 22, 2024** Six Acres Water Company must complete and return to the State Water Board the "Notification of Receipt" form attached to this amended compliance

order as Enclosure 3. Completion of this form confirms that Six Acres Water Company has received this amended compliance order and understands that it contains legally enforceable directive(s).
