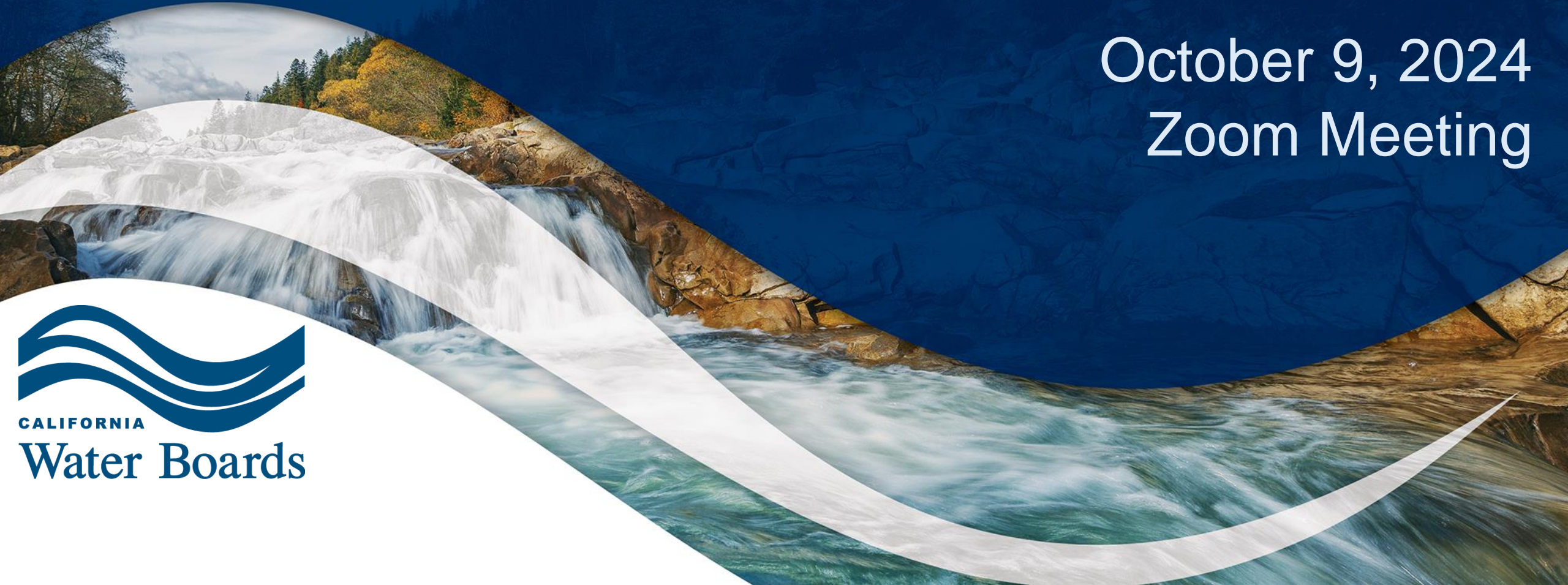

Input Forum #1 Q&A Topic Responses

Topic	Response
Posting of Input Forums	Posted the Input Forum #1 and will post #2 video and slides to our eAR website
eAR Deadline	DDW will release the eAR annually on February 1. Annual deadline will be 60 days after release.
Duplicative Data	We are continuing to evaluate the eAR for duplicative data collection and will address when feasible. (i.e., LSLI and Backflow)
Section 8 Removal	We are evaluating the feasibility and timeline to move Section 8 over to the SAFER Clearinghouse. We will provide more information as this effort continues.
MFA Implementation (WBKey)	We understand the importance of eAR security and the challenges of lead service line authentication. We're working with our Water Board partners to meet these requirements while minimizing impact on water systems.

- Anticipating release date is February 1, 2024.
- Deadline date will be 60 days after release date.

Technical Reporting Order

- Release on January 1, 2025 – includes all public water system reporting requirements for eAR and SAFER Clearinghouse portals.
- Designed to handle multiple public water system types, frequencies, and report types in one order.
