The State Water Resources Control Board (State Water Board) invites you to attend a public meeting to learn about the potential consolidation of San Lucas County Water District (San Lucas CWD) with California Water Service King City District (Cal Water).

BACKGROUND

On June 10, 2025, the San Lucas CWD board voted in favor of seeking a managerial consolidation with Cal Water. In September 2025, the State Water Board issued a letter to San Lucas CWD and Cal Water addressing consolidation. The process includes a period for San Lucas CWD and Cal Water to negotiate consolidation voluntarily. The purpose of this public meeting is to inform customers about the potential consolidation and to provide an opportunity for public comment.
