Subject: Temporary Flow Requirement Adjustment, starting August 20, 2025, Temporary Amendment to Addendum 4 of Order WR 2024-0006-DWR

To: Shasta River Watershed Water Right Holders (sent to water right holders for which the Board has email addresses) and Interested Parties on Scott-Shasta Drought and Flows E-mail List

This is a temporary amendment to [Addendum 4 of Order WR 2024-0006-DWR](#), which is enclosed for reference. The State Water Resources Control Board (State Water Board) is temporarily amending *Addendum 4: Reinstatement of Conditional Curtailments for Most Junior Water Rights in the Shasta River Watershed*, to authorize alternative flows recommended by the California Department of Fish and Wildlife (CDFW).

Water right holders with a water right priority date of or junior to November 25, 1912 must coordinate and/or curtail diversions to meet the flow requirement in the Shasta River watershed established under the [Emergency Regulation](#).¹ Without this change, the minimum flow requirement for August – September 15 is 50 cubic feet per second (cfs) at the [Yreka United States Geological Survey \(USGS\) gage](#). This amendment *temporarily* changes the flow requirement that water rights holders must meet to the flows in Table 1 below, starting with today, August 20, 2025, as Day 1.

* Days with two flows indicate a day of ramping between the two flows indicated. Every attempt shall be made to ramp the applicable flow down in 5 cfs increments over 12 hours per the change in flow.

As background, Section 875, subsection (c)(2)(D) of the Emergency Regulation,

allows for CDFW, in coordination with the National Marine Fisheries Service (NMFS), to propose alternative flows at the Yreka USGS gage for a limited period to collect temperature and other information to evaluate whether such alternative flows can provide equal or better protection for the pertinent species' relevant life stages.

CDFW submitted a letter to the State Water Board, dated August 4, 2025, proposing that the Deputy Director of the Division of Water Rights (Deputy Director) implement alternative flows over 15 days starting in the second half of August. The proposed flow schedule (Table 1 above) includes a reduction below the emergency minimum flow of 50 cfs for about seven days, followed by a ramp-up to flows greater than the 50 cfs flow requirement – to 60 cfs – for the remainder of the alternative flow period, with a final day of ramp-down to 50 cfs.

During this 14-day period, CDFW will monitor fish condition and habitat use, with focused surveys in identified summer refuge habitat in the Shasta Canyon. The recommendation to amend the flow schedule includes an important caveat that if evidence of adverse impacts caused by reduced flows is observed, CDFW may recommend that the State Water Board immediately suspend the alternative flow schedule and reinstate the emergency minimum flows as defined in the Emergency Regulation.

The alternative flow schedule was developed in coordination with the Scott Valley and Shasta Valley Watermaster District (Watermaster) and the Siskiyou County Farm Bureau. The additional water right holders that may need to curtail their diversions to achieve the alternative flow schedule have been identified and have agreed to meet the higher flows to support implementation of the alternative flow schedule. The Watermaster will ensure that the scheduled flows are met during the implementation period in accordance with the Shasta River Adjudication².

On August 20, 2025, the Board received confirmation that the affected water rights holders agree to meet the increased flows. Also today, CDFW requested that the alternative flow schedule start today, and the Watermaster indicated it was possible implement the range of flows in Table 1 starting today and will maintain the flows in Table 1. Therefore, as noted above, starting today, August 20, 2025, the required flows for the 14-day period noted in Table 1 that water users in the Shasta River must meet under Order WR 2024-0006-DWR are described in Table 1, above. The flow requirements in [Emergency Regulation](#), section 875 (c)(2)(A) (i.e., 50 cfs from Sept. 1-15, 75 cfs from Sept. 16-30, etc.) shall resume upon expiration of this temporary amendment. **This temporary amendment expires at the end of the day on September 2, 2025 (or earlier if CDFW notifies the State Water Board that the alternative flows should be suspended due to negative impacts of reduced flow).**

Subject: Order WR 2024-0006-DWR, Addendum 4: Reinstatement of Conditional Curtailments for Most Junior Water Rights in Shasta River Watershed

To: Shasta River Watershed Water Right Holders (sent to water right holders for which the Board has email addresses) and Interested Parties on Scott-Shasta Drought and Flows E-mail List

The State Water Resources Control Board (State Water Board or Board) is reinstating conditional curtailments for junior water rights in the Shasta River watershed. **Water right diverters with a priority date of or junior to January 1, 1958, which are noted in Attachment A to this addendum, may divert under their priority of right when specific conditions outlined in this addendum (outlined below) are met.** The remaining water right holders in Attachment A (between November 25, 1912 through December 31, 1957) are conditionally curtailed and are directed to work with the Scott Valley and Shasta Valley Watermaster District (Watermaster) and State Water Board, as appropriate, and if necessary curtail in order of priority to ensure the required minimum flows are met and sustained at the [Yreka United States Geological Survey \(USGS\) gage](#). For reference, the required minimum flow at the Yreka USGS gage for May 1 – September 15 is 50 cubic feet per second (cfs).

Background. On June 7, 2024, the State Water Board issued a curtailment order ([Order WR 2024-0006-DWR](#) or Order) to water right holders in the Shasta River watershed, including all post-Adjudication appropriative surface water rights and appropriative groundwater rights described in section 875.5, subdivision (b)(1)(A) of the [Emergency Regulation](#)¹, as well as more senior appropriative rights with priority dates of or junior to November 25, 1912, as described in section 875.5, subdivision (b)(1)(B). The Order conditionally curtailed water rights and requires coordination of future diversions with the Watermaster or the State Water Board. The Order notes that if this coordination proved insufficient to achieve and maintain the minimum baseline flow requirement, then a curtailment based on priority will be enforced. Furthermore, the Order establishes additional conditions for water rights junior to January 1, 1958, which become applicable when flows fall below 55 cfs.

On June 21, 2024, the Board noticed the most junior water rights with a priority of or junior to January 1, 1958, that their status changed from “conditionally curtailed” to “curtailed” and they must cease diversions immediately.

On July 3, 2024, the State Water Board issued the [first addendum to the Order](#) reinstating conditional curtailments for most junior water rights in the Shasta River watershed, meaning that water right diverters with a priority date of or junior to January 1, 1958 may divert under their priority of right when specific conditions outlined in that addendum were met.

On October 25, 2024, with improved flow conditions and the beginning of the rainy season the Board issued a [second addendum to the Order](#) temporarily suspending all curtailments through the end of the month. by On October 31, 2024, the Board issued a [third addendum to the Order](#) suspending all curtailments in the Shasta River watershed.

Since January 1, 2025, flows at the Yreka USGS gage have been dynamic with the maximum daily flow of 2,210 cfs on February 4, 2025, and minimum daily flow of 56.8 cfs on June 26, 2024. The Yreka USGS gage flows have been on a declining trend since June 22, 2025. The flow at 3:00 pm on June 27, 2025 is 53.1 cfs. The snowpack data shows no significant snow cover remaining in the watershed, and the precipitation forecast for the next 10 days is negligible. Historical flows at the Yreka USGS gage demonstrate that Shasta River flows are highly impacted by surface water diversions and groundwater pumping through the irrigation season. There is a good chance for flows to drop below the minimum fish flow requirements during the summer similar to the hydrology in the past.

Accordingly, this addendum is issued to reinstate conditional curtailments for all post-Adjudication appropriative surface water rights and appropriative groundwater rights described in section 875.5, subdivision (b)(1)(A) of the [Emergency Regulation](#), as well as more senior appropriative rights with priority dates of or junior to November 25, 1912, as described in section 875.5, subdivision (b)(1)(B). Based on conversations with the Watermaster, there may be limited opportunities when water is available for diversion by the most junior water rights such that conditional curtailment may provide for limited water diversions that do not harm more senior water rights holders. This addendum provides flexibility based on close coordination with the Watermaster and consistent with the specific conditions outlined below.

Specific Conditions that Must be Met for Water Rights (with a priority date of or junior to January 1, 1958) to Divert. Water rights holders with a priority of or junior to January 1, 1958 must do all of the following while conditionally curtailed under this addendum:

- (1) Prior to diverting water, the water right holder shall consult with and receive confirmation from the Watermaster there is water available for diversion under their priority of right and that such diversion will not impact other more senior water rights holders. The water right holder shall not divert until the Watermaster has confirmed that there is water available. The diverter shall document such consultation and confirmation (e.g., save emails), and provide records of such consultation upon request by the Board.

- (2) The water right holder shall notify the Watermaster and State Water Board when diversion commences, including the amount of water being diverted and any changes to the diversion amount.
- (3) The water right holder shall cease diversion immediately upon notification from the Watermaster or State Water Board that there is no longer water available under their priority of right, such that continued diversion will not provide for the minimum flow requirement to be met or a more senior water right holder to divert under their higher priority water right. The water right holder shall provide notification to the Watermaster and Board when such diversion has ceased.
- (4) When diverting, the water right holder shall check the Yreka USGS gage and [Department of Water Resources Shasta River at Grenada Pump Plant \(SPU\) gage](#) at least daily. Additionally, the water right holder shall:
 - Reach out to the Watermaster and consult on flow conditions when flows at the Yreka USGS gage are at or below 55 cfs and flows at the SPU gage are declining. Water rights holders should reduce or cease diversions under such conditions to ensure flows are met and sustained at the Yreka USGS gage.
 - Under no circumstances divert when the minimum instream flow requirement is not being met at the Yreka USGS gage.

Failure to implement any of the above conditions is subject to enforcement under the Emergency Regulation.

Notification and Consult with Watermaster and State Water Board. Water rights holders with a priority of or junior to January 1, 1958 that are seeking to consult with the Watermaster on the availability of water for diversion under their priority right or to report on the initiation or cessation of diversion as noted in Items 1-4 above should email the Watermaster at: deputy@sswatermaster.org. Associated communications with the Board should be emailed to: ScottShastaFlows@waterboards.ca.gov.

In accordance with provision 4 of Order WR 2024-0006-DWR, the Board may notice water rights holders of the need to immediately curtail to meet and sustain the flow requirement at the Yreka USGS gage, in which case this addendum will no longer be in force and effect for those water rights identified in the notice.

The State Water Board will continue to monitor weather forecasts, stream gages, diversions, and watershed conditions regularly to determine if further adjustments to curtailments are appropriate.
