RESCISSION OF CEASE AND DESIST ORDER NO. R6T-2006-0034

DISCHARGE AND THREATENED DISCHARGE OF WASTE
IN VIOLATION OF WASTE DISCHARGE REQUIREMENTS
CONTAINED IN BOARD ORDER NO. 6-95-86A2

The California Regional Water Quality Control Board, Lahontan Region (Water Board) finds:

1. The Water Board established updated Waste Discharge Requirements for Homewood Mountain Resort, hereinafter referred to as the Facility, under Board Order No. 6-95-86 on July 14, 1995. The Facility is a ski area located in the unincorporated Homewood community in Placer County on the west shore of Lake Tahoe. On March 13, 2002, the Water Board adopted amended Board Order No. 6-95-86A2 that extended the compliance date to October 15, 2003 for the installation of Best Management Practices (BMPs) to control sources of erosion and wastes in stormwater runoff from base area parking lots, buildings, and maintenance facilities. Installation of the required BMPs was not completed by October 15, 2003.
2. The Water Board adopted Cease and Desist Order No. R6T-2006-0034 on July 26, 2006 for Homewood Village Resort, LLC, hereinafter referred to as the Discharger. The Discharger acquired controlling interest in the Facility on June 1, 2006. Cease and Desist Order No. R6T-2006-0034 included a provision rescinding Cease and Desist Order No. R6T-2006-0007 against JAY, LLC, the previous owner of the Facility.
3. Cease and Desist Order No. R6T-2006-0034 required the Discharger to cease and desist from discharging or threatening to discharge wastes in violation of waste discharge requirements in Board Order No. 6-95-86A2 by completing installation of drainage treatment and control facilities and BMPs to comply with waste discharge requirements by October 15, 2006. Cease and Desist Order No. R6T-2006-0034 also established interim compliance and reporting dates, and required a Final Report to confirm that the Discharger completed installation of drainage control facilities and BMPs to comply with waste discharge requirements.

4. The Discharger has installed BMPs to control the sources of erosion and wastes in stormwater runoff from the base area facilities, as required in Cease and Desist Order No. R6T-2006-0034, and has submitted reports and plans as required. The Discharger is therefore in compliance with Cease and Desist Order No. R6T-2006-0034.
5. Rescission of Cease and Desist Order No. R6T-2006-0034 is not against the public interest. Future discharges of waste must be in compliance with the waste discharge requirements prescribed in Board Order No. 6-95-86A2.
6. The Board has notified the Discharger and interested persons of its intent to rescind Cease and Desist Order No. R6T-2006-0034.
7. The Board in a public hearing heard and considered all comments pertaining to this rescission Order.

IT IS HEREBY ORDERED that Cease and Desist Order No. R6T-2006-0034 be rescinded.
