AGENT FOR SERVICE OF PROCESS AND PROCEDURE FOR PUBLIC RECORDS ACT REQUESTS July 17, 2023

In order to ensure that subpoenas, summons and complaints or other legal proceedings against the California Regional Quality Control Board, Lahontan Region (Lahontan Water Board), and requests pursuant to the California Public Records Act (Government Code § 6250 et seq.) are routed to the appropriate personnel and timely addressed,

A. Service of Subpoenas

1. Only the following personnel, and only in the following order, are authorized to receive service of a subpoena, including a subpoena duces tecum, for business records, persons most knowledgeable (PMK), the personal appearance by any staff member (in his/her capacity as such), or for any other subpoena directed to the Regional Board (or any of its personnel in their capacity as such):

4. Individual staff members are NOT authorized to receive service of a subpoena, even if the individual staff member is identified as the deponent.
5. The Lahontan Water Board will not accept service of a subpoena involving a matter that is unrelated to Lahontan Water Board business.

B. Service of Summons or Complaint or Other Legal Action or Process

1. Only the following personnel (or their designees) are authorized to receive service of a summons relating to a civil complaint, a petition for writ of mandate, or other legal action or process against the Lahontan Water Board:
