**Subject:** Proposed Revisions to Lake Tahoe Laundry Works CAO

On July 18, 2016, the Lahontan Regional Water Quality Control Board's Prosecution Team submitted a memo to Patty Kouyoumdjian, the Water Board's Executive Officer, which contained recommendations for revisions to the draft CAO that went out September 15, 2015. The revised draft version included an additional responsible party. The Prosecution Team recommended allowing an additional 30-day comment period, allowing Bobby Page's Inc an opportunity to comment on the entire CAO, but limiting comments by existing parties (Fox Capital Management Corporation and Seven Springs Limited Partnership) and the public to the issues of adding Bobby Page as a responsible party and on the revised requirements that require a more extensive off-site investigation and clean-up requirements extending to the Tahoe Keys Water Company Well #2.

The Advisory Team agrees with this recommendation. Comments from all parties and the public must be received by 5pm Thursday, September 8, 2016. Because Bobby Page's Inc was not previously named as a responsible party, it shall have the opportunity to comment on the entire CAO. Fox Capital Management Corporation and Seven Springs Limited Partnership, who already provided significant comments on the draft CAO, should limit any new comments to the incorporation of Bobby Page's Inc as a responsible party and to the revised requirements for a more extensive off-site investigation and clean-up requirements extending to the Tahoe Keys Water Company Well #2. Interested members of the public should also limit any comments to these revisions.
