Project Description: The U.S. Forest Service – Lake Tahoe Basin Management

Unit (LTBMU) will restore portions of the Blackwood Creek watershed affected by historic disturbances by constructing rock and log structures in the channel and on the floodplain, realigning select channel segments, restoring connectivity to

historic channels, grading floodplain surfaces, and revegetating with native riparian species. Floodplain surfaces will be regraded as needed and stabilized with

coarse native substrate.

The restoration work will involve the discharge of waste earthen materials to waters of the State. Such discharges are subject to regulation pursuant to the California Water

Code section 13263.
