Upon presenting the Board's response to The People of Hinkley, note of the following comments:

1. The Petition must remain as a Petition. (Inherent Constitutional right vested to the People to Petition for redress and grievances.) [Emphasis added]
2. The Board is instituted by the People to do all those things in protecting the People and not to shield or minimize PG&E's from strict liability, and not limited to insulting The People by its action or inaction.
3. If the Board is to treat the Petition as a comment, The People of Hinkley will rise and treat the Board's action as shielding PG&E from strict liability.

THEREFORE, if the Board position is as expressed herein, then The People of Hinkley will be left with no other alternative to seeking legal remedy in the appropriate judicial venue.
