The California North Coast Regional Water Quality Control Board (Regional Water Board or Board) will consider adoption of Resolution No. R1-2026-0005 (Resolution) for Project Criteria for an Exception to the Enclosed Bays and Estuaries Policy (Policy) and the Prohibition of Waste Discharges to Humboldt Bay.

The City of Eureka is currently enrolled under National Pollutant Elimination System (NPDES) Order No. R1-2023-0016 (Order). The purpose of this Resolution is to describe the North Coast Regional Water Quality Control Board's (Regional Water Board or Board) understanding of the project criteria that may justify an exception to the waste discharge prohibition contained in the Policy and Order. This is not an action to modify or approve revisions to the Order, or to formally approve projects to satisfy the Policy or Order conditions.

This item was originally open for written public comment between **November 7**, **2025** and **December 8**, **2025**. To encourage broad public participation, the Regional Water Board staff is extending the public comment period to **December 15**, **2023**. Oral comments will also be accepted at the above scheduled hearing. The time constraints for oral comments will be set by the Chair of the Regional Water Board and are generally limited to no more than five minutes for interested persons. Staff and Permittee presentations are generally limited to 20 minutes. These limits may be modified by the Chair upon request and at the Chair's discretion.
