NOTICE OF AVAILABILITY FOR PUBLIC COMMENT AND NOTICE OF PUBLIC MEETING ON AN AMENDMENT TO THE WATER QUALITY CONTROL PLAN FOR THE COASTAL WATERSHEDS OF LOS ANGELES AND VENTURA COUNTIES FOR THE ADDITION OF THREE NEW BENEFICIAL USE DEFINITIONS: TRIBAL TRADITION AND CULTURE (CUL), TRIBAL SUBSISTENCE FISHING (T-SUB) AND SUBSISTENCE FISHING (SUB) AND SUBSTITUTE ENVIRONMENTAL DOCUMENTATION

NOTICE IS HEREBY GIVEN THAT the State Water Resources Control Board ("State Water Board") is seeking written public comments on the California Regional Water Quality Control Board, Los Angeles Region ("Regional Water Board") amendment to the Water Quality Control Plan for the Coastal Watersheds of Los Angeles and Ventura Counties for the addition of three new beneficial uses definitions: Tribal Tradition and Culture (CUL), Tribal Subsistence Fishing (T-SUB) and Subsistence Fishing (SUB) ("Basin Plan amendment") and the supporting final Substitute Environmental Documentation ("SED").

#### **BACKGROUND**

The Los Angeles Water Board's Water Quality Control Plan (Basin Plan) contains water quality standards for the coastal watersheds of Los Angeles and Ventura Counties in the Los Angeles Region. Chapter 2 of the Basin Plan contains beneficial uses that form the cornerstone of water quality protection in the region. Beneficial uses are mandated for all waterbodies within the state under the California Water Code. Since the first iteration of the Basin Plan in 1975, 25 beneficial uses have been identified by the Los Angeles Basin Plan.

On May 2, 2017, the State Water Resources Control Board (State Water Board) adopted Resolution No. 2017-0027, which approved "Part 2 of the Quality Control Plan for Inland Surface Waters, Enclosed Bays, and Estuaries of California—Tribal and Subsistence Fishing Beneficial Uses and Mercury Provisions". The provisions define the tribal tradition and culture (CUL), tribal subsistence fishing (T-SUB), and subsistence fishing (SUB) beneficial uses that should be used by Regional Water Quality Control Boards, including Los Angeles Water Board.

The Regional Water Board adopted the Basin Plan amendment and approved the SED on March 10, 2022, by Resolution No. R22-001.

The proposed amendment to the Basin Plan will add three new beneficial use definitions to Chapter 2 of the Basin Plan: Tribal Tradition and Culture (CUL), Tribal Subsistence Fishing(T-SUB), and Subsistence Fishing (SUB). The proposed amendment is intended to update the Basin Plan with the more current information.

The proposed amendment also advances the Water Boards' commitment to making racial equity and environmental justice central to implementing the agency's mission (State Water Board Resolution No. 2021-0050). Part of the Water Boards' commitment in this regard is to recognize the important uses of water resources by California Native American Tribes for food sources and cultural, spiritual, and traditional ways of living and to improve communication, working relationships, and co-management practices with California Native American Tribes.

Persons interested in the Basin Plan amendment are encouraged to submit comments electronically. Comment letters must be received **by 12:00 noon on September 1923, 2022**. Comment letters received after that deadline will not be accepted unless the State Water Board determines otherwise.

#### REQUIREMENTS FOR SUBMITTING COMMENTS

In accordance with California Code of Regulations, title 23, section 3779, subdivision (f), the State Water Board may refuse to accept any comment that does not satisfy all of the following requirements:

- 1. Comments must specifically address the final version of the Basin Plan amendment adopted by the Regional Water Board.
- If the Regional Water Board previously responded to a similar or identical comment, the commenter must explain why and in what manner the commenter believes each of the responses provided by the Regional Water Board to each comment was inadequate or incorrect.
- 3. The commenter also must include either a statement that each of the comments was timely raised before the Regional Water Board, or an explanation of why the commenter was unable to raise the specific comment before the Regional Water Board.

**NOTICE IS FURTHER HEREBY GIVEN THAT** the State Water Board will consider adopting a resolution to approve the Basin Plan amendment and SED.
