**NOTICE IS HEREBY GIVEN** that State Water Resources Control Board (State Water Board) will accept written comments, and any directly related evidence, on only the revisions to the antidegradation findings, as set forth in Section I.H of the Fact Sheet of the proposed Statewide Construction Stormwater General Permit.

**NOTICE IS ADDITIONALLY HEREBY GIVEN** that State Water Board staff will hold a public workshop to provide interested parties an overview of the proposed Permit, including proposed revisions in response to public comments received during the March 30, 2022 through May 2, 2022 limited-scope public comment period.

### BACKGROUND

The federal Clean Water Act requires discharges of construction stormwater to waters of the United States to be regulated by a National Pollutant Discharge Elimination System (NPDES) permit. The State Water Board adopted the existing statewide NPDES Construction Stormwater General Permit in 2009 to regulate stormwater discharges associated with construction activities disturbing one or more acres of land or less than one acre but are part of a larger common plan of development or sale that totals one or more acres of land disturbance. The existing statewide General Permit expired on September 2, 2014 and is administratively extended until the effective date of a reissued permit.

The proposed statewide General Permit reissuance incorporates:

- New requirements to implement existing total maximum daily loads (TMDLs) adopted by Regional Water Quality Control Boards into applicable basin plans;
- New requirements to address discharges from passive treatment technology uses and dewatering activities;
- New eligibility criteria for permit enrollment through a Notice of Non-Applicability;
- Updates to the existing Notice of Termination process;

- Requirements to implement the California Ocean Plan and amendments to the Water Quality Control Plan for Inland Surface Waters, Enclosed Bays, and Estuaries, including the statewide Trash Provisions;
- Updated requirements for demolition activities;
- Updated water quality sampling requirements per the federal Sufficiently Sensitive Test Methods Rule;
- Updated monitoring and reporting requirements;
- Antidegradation findings that comply with federal and state antidegradation policies; and
- New programmatic permitting permit enrollment options for linear utility construction projects.

At the State Water Board public meeting for Board consideration of adoption, there will be no sworn testimony or cross-examination of participants. However, the State Water Board and its staff may ask clarifying questions. Participants will be given an opportunity to provide oral presentations. To ensure a productive and efficient Board meeting in which all participants have an opportunity to participate, oral presentations may be time limited.

The State Water Board will accept written comments, including any directly related evidence, on only the revisions to the antidegradation findings in Section I.H.2 of the Fact Sheet in the proposed Statewide Construction Stormwater General Permit. Written comments must clearly relate to the antidegradation revisions. Written comments or evidence that address other components of the proposed Permit reissuance will not be accepted. Written comments and accompanying evidence regarding the revisions to the proposed antidegradation findings must be received no later than **12:00 p.m. (noon) on Tuesday, August 23, 2022.** Written comments must be addressed to:
