

**NONPOINT SOURCE POLLUTION RELATED REPORTS  
PREPARED PURSUANT TO THE FEDERAL CLEAN WATER ACT  
AND THE COASTAL ZONE ACT REAUTHORIZATION AMENDMENTS OF 1990**

California Water Code section 13369(b) requires that the State Water Resources Control Board (SWRCB), in consultation with the California Coastal Commission (CCC) and other appropriate agencies, submit to the Legislature and make available to the public the following information on or before August 1 of each year:

1. Copies of all SWRCB and Regional Water Quality Control Boards (RWQCBs) reports that contain nonpoint source pollution related information that were prepared in the previous fiscal year (FY) pursuant to the federal Clean Water Act (CWA) sections 303, 305(b) and 319 and the federal Coastal Zone Act Reauthorization Amendments of 1990 (CZARA) section 6217; and
2. A summary of information related to nonpoint source pollution that is set forth in those reports.

Five reports were prepared and submitted to the U.S. Environmental Protection Agency (U.S. EPA) in FY 2002-03 as required under CWA sections 303, 305(b) and 319 and CZARA section 6217. The following is a list of the reports and a brief summary of each report.

1. *Annual Assessment Report (July 2001 through June 2002) – Nonpoint Source (NPS) Implementation, CWA Section 319 Grant #C9-98998901-0.* This report provides an updated review of the many activities undertaken at the state and regional level to control NPS pollution. The report includes information on state-wide and region-specific measures and identifies priority and emerging NPS issues. The report was submitted to U.S. EPA on September 30, 2002.
2. *Semi-Annual Progress Report (January through June 2002) – Nonpoint Source Implementation, CWA Section 319 Grant #C9-98998901-0.* This report updates progress on the original tasks proposed in the Nonpoint Source Implementation Workplan for FY 2001-02 for the period January 1, 2002 through June 30, 2002. The report was submitted to U.S. EPA on August 2, 2002.
3. *Semi-Annual Progress Report (July through December 2002) – Nonpoint Source Implementation, CWA Section 319 Grant #C9-97920402-0.* This report updates progress on the original tasks proposed in the Nonpoint Source Implementation Workplan for FY 2002-03 for the period July 2002 through December 2002. The report was submitted to U.S. EPA on January 31, 2003.
4. *Semi-Annual Progress Report (July through December 2001) – Nonpoint Source Implementation, CWA Section 319 Grant #C9-98998901-0, Addendum Number 2.* This report from the San Diego RWQCB completes its submittal requirements for years 2001-02. This report was submitted to U.S. EPA on August 2, 2002.
5. *2002 California 305(b) Report on Water Quality; prepared as required by the Federal Clean Water Act Section 305(b).* This report, required to be submitted every two years, provides information on the surface water quality assessment including total waters assessed and programs to assess, preserve, maintain and restore water quality. This report includes the CWA 303(d) list adopted by the SWRCB, but not yet approved by U.S. EPA. The final report was submitted to U.S. EPA on March 28, 2003. U.S. EPA has proposed changes to the 2002 303(d) list; those changes will be incorporated into the 305(b) report once the changes are made final. The report then will be re-submitted to U.S. EPA.
