## NOTICE OF PUBLIC HEARING AND WRITTEN COMMENT PERIOD

The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) is releasing for public review and comment, Tentative Order No. R9-2026-0001, Amending Order No. R9-2010-0032 Waste Discharge Requirements and Master Reclamation Permit for the City of Escondido, Hale Avenue Resource Recovery Facility and Order No. R9-2023-0131 Waste Discharge Requirements for the City of Escondido Membrane Filtration and Reverse Osmosis Facility (Tentative Order). The Tentative Order, if adopted, will remove the color effluent limitation and monitoring requirement from Order Nos. R9-2010-0131 and R9-2023-0131.

The San Diego Water Board will prepare written responses to significant comments that are timely received. Consistent with State Water Resources Control Board regulations that apply to this proceeding, written comments received after **5:00 p.m. on Friday, January 9, 2026**,

may not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party.
