*Waste Discharge Requirements for the City of San Diego South Bay Water Reclamation Plant (SBWRP) Discharge to the Pacific Ocean Through the South Bay Ocean Outfall*

#### Please Take Notice

The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) is releasing for public review and comment Tentative Order No. R9-2026-0006 *Amending Order No. R9-2021-0011, NPDES No. CA0109045 Waste Discharge Requirements for the City of San Diego South Bay Water Reclamation Plant (SBWRP) Discharge to the Pacific Ocean Through the South Bay Ocean Outfall (SBOO)* (Tentative Order). If adopted, the Tentative Order will update the City of San Diego's NPDES permit to reflect 1) changes to pH monitoring requirements; 2) the reduced frequency of the local limits evaluation to once per five years; 3) the use of 24-hour composite or grab samples for the following parameters in effluent monitoring: ammonium, total nitrogen, total organic nitrogen, nitrate (as N), nitrite (as N), total phosphorus (as P), phosphate, total organic carbon, dissolved inorganic carbon, total iron, dissolved iron, alkalinity, and salinity; 4) reporting of nitrate and nitrite as N; 5) changes to the deadline to submit receiving water monitoring results to the California Environmental Data Exchange Network (CEDEN); 6) updates to flow, outflow operations, and dilution factor in the SBOO in response to the 10 million gallon per day (MGD) expansion of the neighboring South Bay International Wastewater Treatment Plant; and 7) the correct description of the SBOO.
