The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) is releasing for public review and comment, Tentative Order No. R9-2026-0101, *An Order Rescinding Order No. R9-2004-0389, Waste Discharge Requirements for DS Waters of America, LP, Lakeside Bottling Plant, San Diego County* (Tentative Order). The Tentative Order, if adopted, will rescind Order No. R9-2004-0389, as amended.

Submission of Written Comments

Notice is hereby given that the San Diego Water Board will accept written comments regarding the Tentative Order in accordance with this notice.

The written comment period provides an opportunity for interested persons to comment on the Tentative Order. All written comments regarding the Tentative Order must be received no later than **5:00 p.m. on Thursday, September 24, 2026**, to be considered by the San Diego Water Board. Comments should be submitted by e-mail to sandiego@waterboards.ca.gov. The subject line of all written comments must include "Comment – Tentative Order No. R9-2026-0101". The early submission of written comments on the Tentative Order is encouraged. Written comments received by **5:00 p.m. on Thursday, September 24, 2026**, will be provided to the San Diego Water Board members for their review in advance of the public hearing to consider the adoption of the Tentative Order. The San Diego Water Board will prepare written responses to significant comments that are timely received. Consistent with State Water Resources Control Board regulations that apply to this proceeding, written comments received after **5:00 p.m. on Thursday, September 24, 2026**, may not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party.
