TENTATIVE ORDER NO. R9-2006-0007, AN ORDER RESCINDING ORDER NOS. 88-67, 94-32, 94-33, 94-62, 94-71, 94-130 AND 96-60

Enclosed is a copy of tentative Order No. R9-2006-0007, which is tentatively scheduled to be presented to the Regional Board for consideration at its meeting on April 12, 2006.

All discharges from the facilities listed below that could impact waters of the State have been terminated and Waste Discharge Requirements are no longer necessary.

Tentative Order No. R9-2006-0007 would, if adopted, rescind the following Waste Discharge Requirements:

5. Order No. 94-71, *Waste Discharge Requirements for Florence Kirkpatrick, Alpine Springs R. V. Resort, San Diego County.*
6. Order No. 94-130, *Waste Discharge Requirements for John and Joanne DeRaadt Dairy, San Diego County.*
7. Order No. 96-60, *Waste Discharge Requirements for the San Diego Unified Port District, National City Marina, San Diego County.*


