### BE INSTRUMENTAL IN THE SUSTAINABILITY OF CALIFORNIA'S MOST ESSENTIAL RESOURCE

The San Diego Regional Water Quality Control Board (Regional Water Board) is looking for an individual willing to commit to the leadership, determination and demands of the position of Executive Officer. The Executive Officer is a key guardian of the State's water resources. The Regional Water Board, along with the State Water Resources Control Board, plays a critical role in the state's health by protecting and improving the water quality of the region's aquifers, rivers, lakes and shores. Working closely with and at the direction of nine board members appointed by the Governor, the Executive Officer oversees a staff of 80 persons, including engineers, geologists, and environmental scientists committed to protecting and enhancing the waters of portions of Orange, Riverside and San Diego Counties.

#### DESIRABLE QUALIFICATIONS

The Regional Water Board encourages applicants representing a wide-range of disciplines to apply. In reviewing candidates, the Regional Water Board considers the following attributes especially desirable: a proven ability to synthesize and explain complicated scientific and public policy issues, excellent interpersonal skills, sound judgment, strong leadership skills, including setting performance standards and evaluating performance, good personnel management skills, strong negotiating skills, solid organizational skills, a demonstrated ability to form collaborative efforts with stakeholders, a familiarity with the federal and state laws regulating water quality, and familiarity with water reclamation/recycling issues. Knowledge and experience in the San Diego Region boundaries of Orange, Riverside and San Diego Counties is desirable. A successful candidate must be able to think, act and work creatively, demonstrate initiative, and effectively deploy limited resources. Applicant shall submit a Statement of Qualifications, maximum 4 pages), as part of their application for review by the Regional Board.

#### MINIMUM QUALIFICATIONS

Experience: At least 10 years experience of broad, responsible, professional experience in one or more of the following: public administration; water quality program management; environmental management; environmental, civil, or sanitary engineering, or related fields providing similar experiences. At least 5 years of required experience must have included supervisory responsibility for a professional staff involving the direction, preparation and implementation of policies and programs in these fields; AND,

#### EDUCATION

Equivalent to graduation from college with a degree in public administration, environmental, civil, chemical or sanitary engineering, environmental law, biological or physical sciences or related fields. (Multiple or advanced degrees in these areas or related fields are desirable.)

As this is an exempt position, it is not necessary to be a current State employee to apply.

All applicants meeting the minimum requirements will be referred to the San Diego Regional Board and only the most qualified will be considered. References may be requested and contacted and interviews may or may not be held.
