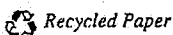
The California Regional Water Quality Control Board, San Diego Region (Regional Board) intends to consider adoption of enclosed subject tentative Order including monitoring and reporting program and fact sheet, at a Regional Board meeting on August 12, 2009. The tentative Order would, if adopted, reissue National Pollutant Discharge Elimination System (NPDES) waste discharge requirements (WDR) for the discharge of waste from both Naval Base San Diego and the USN Graving Dock. Changes from the previously released version of the subject NPDES Order are shown in underline/strikeout format.

Please note that the subject tentative Order incorporates NPDES requirements for the USN Graving Dock that were contained in Order No. R9-2003-0265, NPDES Permit No. CA0107867.

The tentative Order will be presented to the Regional Board on Wednesday, **August 12, 2009**. The meeting will begin promptly at 9:00 AM and will be held at the following location:

The public comment period will remain open until the Regional Board takes action on August 12, 2009. However, to ensure that the Regional Board has the opportunity to fully study and consider written material, comments should be received in the Regional Board's office no later than 5:00 p.m. on Wednesday, July 29, 2009 for the first mailing to the Regional Board members. The final deadline for submittal of written comments is 5:00 p.m. on August 5, 2009 for the last mailing to Regional Board members.
