Enclosed is a copy of Tentative Order No. R9-2011-0019, NPDES Permit No. CA0107395, *Waste Discharge Requirements for the Encina Wastewater Authority Encina Water Pollution Control Facility and Satellite Wastewater Treatment Plants Discharge to the Pacific Ocean via the Encina Ocean Outfall*. Tentative Order No. R9-2011-0019 includes a monitoring and reporting program and fact sheet. The Tentative Order No. R9-2011-0019 is scheduled to be considered by the California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) for adoption at their regularly scheduled meeting on April 13, 2011.

If adopted, Tentative Order No. R9-2011-0019, NPDES Permit No. CA0107395, would update waste discharge requirements for the discharge of treated wastewater effluent and brine from the Encina Water Pollution Control Facility, Meadowlark Water Reclamation Plant, Shadowridge Water Reclamation Plant, and Carlsbad Water Reclamation Facility, to the Pacific Ocean via the Encina Ocean Outfall. Order No. R9-2011-0019 would supersede Order No. R9-2005-0219.

The April 13, 2011 meeting will begin promptly at 9:00 a.m. and is currently scheduled to be held at the following location:

Written material submitted to the staff after the final submittal deadline date will not be provided to the San Diego Water Board. Also it is not likely that written material will be accepted by the San Diego Water Board on the day of the meeting.
