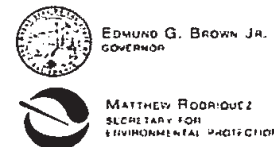

The California Regional Water Quality Control Board San Diego Region (San Diego Water Board) will hold a hearing and consider adoption of Tentative Addendum No. 2 to Order No. 99-74 at its scheduled meeting on Wednesday, June 19, 2013.

The tentative Addendum, if adopted, will modify Order No. 99-74, *Waste Discharge Requirements for the Sycamore Landfill Inc., a Subsidiary of Republic Services Inc., Sycamore Landfill, San Diego County*. The proposed Addendum includes modifications to the geotechnical design criteria and incorporates an engineered alternative liner design for the Stage III-B expansion area at the Sycamore Landfill as requested by the Discharger.
