NOTICE OF PUBLIC HEARING AND WRITTEN COMMENT PERIOD

The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) is releasing Tentative Order No. R9-2016-0127 (Tentative Order), *An Order Rescinding Orders Nos. 86-24, 88-44, and 94-46* for public review and comment. The San Diego Water Board will also consider adoption of the Tentative Order at its regularly scheduled meeting on **August 10, 2016**. The Tentative Order, if adopted, would rescind the following Waste Discharge Requirements (WDRs) Orders:

1. Order No. 86-24, *Waste Discharge Requirements for Discharge of Domestic Wastewater from the Prince of Peace Abbey, San Diego County.*
2. Order No. 88-44, *Waste Discharge Requirements for American Adventure, Butterfield Country Recreational Vehicle Resort, Riverside County.*¹
3. Order No. 94-46, *Waste Discharge Requirements for the County of Orange General Services Agency, Los Pinos Forestry Camp Orange County.*

The discharges from the onsite wastewater treatment systems located at each of the facilities will be enrolled in Order No. WQ 2014-0153-DWQ, *General Waste Discharge Requirements for Small Domestic Wastewater Treatment Systems.*²

Please review and provide any written comments on the Tentative Order **by 5:00 p.m. on July 11, 2016**. Comments should be submitted via email to sandiego@waterboards.ca.gov in text searchable Portable Document Format (PDF) or Microsoft Word format. Written comments can also be submitted via regular mail to the San Diego Water Board office at 2375 Northside Drive, San Diego, CA 92108. Please indicate in the subject line of the email or comment letter "Comment – Tentative Order No. R9-2016-0127, Attn: Fisayo Osibodu."

The early submission of written comments on the Tentative Order is encouraged. Written comments received by **5:00 p.m. on July 11, 2016**, will be provided to the San Diego Water Board members for their review in advance of the public hearing to consider adoption of the Tentative Order. The San Diego Water Board will prepare written responses to significant comments that are timely received. Consistent with State Water Resources Control Board regulations that apply to this proceeding, written comments received after **5:00 p.m. on July 11, 2016**, will not be accepted, and will not be incorporated into the administrative record if doing so would prejudice any party.

Public Hearing for Consideration of Tentative Order

A public hearing on the Tentative Order will be held during the San Diego Water Board meeting on **August 10, 2016**. The meeting will begin promptly at **9:00 AM** and will be held at the **City of Mission Viejo, Council Chambers, 200 Civic Center Drive, Mission Viejo, California..**
